For more than 75 years, our faith has inspired us to serve children close to home and around the world. Why do we do this work? Because there's a sobering gap between the way God sees people and the way the world sees people. Until everyone sees people the same way God does, until every person is loved, connected, and empowered, people need to stand up, speak out, and advocate, loudly and courageously. So that's what we do. Our core beliefs are simple: We love God and we love people.

We are very upfront with all referral agencies about the Christian origin, motivation and organizational structure through Church partnerships. This is a witness in and of itself to many secular workers in our community.

We also share this with each family-in-crisis that reaches out for help and offer prayer. Every volunteer has the opportunity to share their faith and motivation to offer biblical hospitality.



Safe Families for Children provides multiple ways for church members of all ages to participate.

Safe Families volunteers are

- <u>Host Families</u>: Screened and approved by Safe Families, Host Families take in children for short periods of time.
- <u>Family Coaches</u>: They are trained to provide resources and casework-like services to Placing Parents. They also ensure that kids are well cared for in Host-Family homes.



- <u>Family Friends</u>: They provide support to placing families (e.g., mentoring and transportation) and Host Families (e.g., babysitting and providing meals).
- Resource Friends: They donate lightly used items such as beds, furniture, and clothing to help parents get back on their feet.
- <u>Safe Families Churches</u>: These are spiritual communities that support Safe Families as a ministry of their church. There are three church levels: Participating Church, Lead Church, and Community Lead Church.

There are ways to get youth and adults involved in diaper drives, gift card offerings, baby showers, and the list could go on and on. We at Bethany know that people want to help others and try to find ways to get people involved to make a difference in someone's life today!!

19. Intended Outcome(s) of the Project Mission:

Since the launch of Safe Families 6 years ago, this ministry has grown from 10 host families and 2 family coaches serving under 3 churches to 80 host families and 30 family coaches under 10 churches. Safe Families emerged impacting 7 children in our pilot semester to nearing our 300th impacted child. Families-in-crisis are hearing about us through a wide variety of sources such as emergency shelter staff, school counselors, hospital & clinic nurses, other non-profit agencies and a spectrum of government employees. In other words, a growing portion of our community has heard about what the local church is doing through Safe Families and recognizes the significance of how it impacts the fragile, vulnerable families they are working with and refer to this ministry on a regular

basis. The churches in Sioux Falls are viewed by a plethora of community members as a credible and dependable solution to preventing child abuse & neglect in Sioux Falls. That is an undeniable success!
